WHAT HAPPENED?
Tell what led to the claim.

On or about Saturday March 8, 2014 the Defendant District of Sechelt, without color of right, wrongly removed 20 signs owned by the Claimant George Goudie regarding the Referendum taking place with respect to the Waste facility being constructed on Surf Circle in the District of Sechet. March 8, 2014 was the date that the referendum did occur. The signs promoted voting against the position taken by the District of Sechelt in the Referendum. None of the signs were within 100 meters of a Polling station. This action violated George Goudie's right to free speech. The value of the signs was \$1,000.00.

Secondly, on or about July 10, 2014 the Defendant District of Sechelt, without color of right, wrongly removed 8 or more "Roof Demossing" signs belonging to George Goudie and situated on private property within the District of Sechelt. The signs did not violate the District of Sechelt's sign by-law. These signs were "disposed of" by the District of Sechelt.

As a result of the foregoing George Goudie has lost business, suffered stress and aggravation, incurred legal expense and lost the value of his signs.
